

#### NCCCO Administers One Millionth CCO Exam

The National Commission for the Certification of Crane Operators (NCCCO) reached a remarkable milestone earlier this year with the administration of its 1.000.000th certification examination. It was exactly 20 years ago to the month that the first CCO written test was administered. For CCO, the momentous occasion marks the realization of a dream that


