ANSI Grants NCCCO Continued Accreditation

NCCCO Fee Restructuring



Effective January 1, 2020, NCCCO will implement a streamlined fee structure for many of its candidate certification and recertification exams, including most paper/pencil tests, computer-based tests, and practical exams. The new fee structure features a single fee for each exam, regardless of which certifications candidates currently hold. The new fees include a new NCCCO certification card issued to certificants each time they add another certification, eliminating the time and expense of ordering updated cards and ensuring that cards show all certifications currently held. NCCCO Policy on Retaking Exams is Updated

Effective October 1, 2019, NCCCO will require candidates who fail a written exam to wait a minimum of four (4) weeks before retesting on the exact same exam. The policy change is to ensure all candidates are treated fairly and candidates retaking exams don't hold an unfair advantage over those taking the exams for the first time because of their familiarity with the exam questions. Did You Know?

Although NCCCO certification exams are developed by subject matter experts with thousands of hours of experience in the field, **candidate feedback** is a vital part of the test maintenance process. On every written exam, candidates have the opportunity to provide feedback on the exam as a whole, or specific exam questions. Candidates taking paper/pencil exams can provide this on a **Question/Comment form** at the test site, while computer-based testing (CBT) candidates have the opportunity to provide feedback electronically at the end of the exam. The Committee that manages the exams reviews every comment to see if any changes should be made to the exams.
